- 4. A customer's Get active for Less access is not transferrable and may only be used by the named customer to access activities or discounts for themselves in Sport Aberdeen venues.
- 5. Get active for Less expiry It is the responsibility of the individual to apply for their Get active for Less to be renewed prior to the expiry date.
